

New Delhi, June 17: A day after news broke of BTS' open-ended "hiatus" and ARMY took a deep breath, the K-pop superstars' music company shed market cap on Wednesday.

The impact was measurable, certainly for HYBE, whose share price fell 27.5 per cent in early trading, briefly knocking off about \$1.7 billion of market capitalization, before rebounding, South Korean media reported.

Hours after a proverbial "last dinner" like scene at the 2022FESTA in Seoul, where leader Namjoon announced a new chapter for the

KPop superband, ARMY around the world woke up to the realisation that as one door closed, of course in BTS' case -- seven individual windows would open.


The photographs taken last month by Scott Fortner, a collector who works to authenticate and verify Monroe memorabilia, showed stretched and buckled fabric and

## Maharashtra plans rock sculptures on mountains

Maharashtra, June 17: The Maharashtra State Road Development Corporation plans to install rock sculptures of prominent Indian historical figures in mountain ranges across the state.

The plan is inspired by Mount Rushmore in the United States, where massive rock sculptures of four presidents — George Washington, Thomas Jefferson, Theodore Roosevelt, and Abraham Lincoln

— adorn a South Dakota mountain range. The site also includes a museum with interactive exhibits.

The corporation wants to replicate the project in Maharashtra and has already floated a tender for a consultant to conduct a feasibility study and prepare a detailed master plan. The consultant will also identify locations for the proposed sculptures to come up.

The project, corporation officials

told The Indian Express, aspired to develop a memorial for leaders and warriors of Indian history, with a special emphasis on heroes from Maharashtra.

The consultant will also evolve an optimal structure for the final projects and assess the financial feasibility of models, such as public-private partnership mode, donor investments, and purely private investment.

Bhubaneswar, June 17: The Simlipal Tiger Reserve including all ecotourism complexes inside it is closed for visitors from June 16, the Simlipal North Forest division said in a tweet on Thursday.

It said the exact date of reopening will be notified later.

All eco-tourism activities including all nature camps will also remain closed until further reopening notice.

## Nepal to shift Everest base camp for safety reasons

Kathmandu, Jun 17: Nepalese authorities are preparing to move its Everest base camp because it is becoming increasingly unsafe, BBC reported on Friday.

The reason for that is increasing global warming and human activity which is causing a melting of the glacier.

The camp, which is on an average used by up to 1,500 people in the spring climbing season, is situated on the rapidly thinning Khumbu glacier.

A new site will be located at a lower altitude, where there is no year-round ice, an official told the BBC.

Researchers say meltwater destabilises the glacier, and climbers say crevasses are increasingly appearing at base camp while they sleep.

The camp currently sits at an altitude of 5,364m. The new one will be located 200m to 400m lower, Adhikari said.

the national park and the wildlife sanctuary is closed every year by mid-June for the safety of tourists in view of monsoon rain.
